EXECUTIVE DIRECTOR'S REPORT – J. Hall (NIP Management Services)

Supplemental Assessment – Mr. Hall presented the results of the 2023 year-end actuarial report, which provide the basis for the recommended supplemental assessment. Mr. Hall reminded members of previous presentations in June 2023 and February 2024 and recommended a supplemental assessment spread proportionately among 51 members. Payments will be spread over 10 years in 20 installments, and payments will not begin until July 1, 2025.

Commissioner Barrick asked for detailed calculations for each member. Mr. Hall said the calculations would be available for members at the next meeting.



Commissioner Barrick asked when members would see the audited financials. Mr Hall responded that the year-end financial audit was underway and would be completed before the June 30 filing deadline. The audit will be available for all members at the next meeting.

Commissioner Krane then asked if the Fund would release an unaudited 4th Quarter 2023 FastTrack report and suggested that the Administrator send all communications between the Fund and the Department. Mr. Hall committed to providing this to all members by the end of the week.

TREASURER'S REPORT – P. DeBlasio

• Treasurer Report – All Bills have been paid and our cash balance is secure.

Commissioner Moehlman asked Mr. Deblasio what was the Fund's audited net position. Mr. DeBlasio reiterated that the financial audit was underway and that his report pertained to the Treasury Report. Otherwise, Mr. DeBlasio referred back to Mr. Hall's comments.

UNDERWRITING REPORT – R. Smith (NIP Management Services)

- **Property Update** 7/1 property renewal has been bound. We have bound a 6-month policy that will see us return to one renewal season. We are in talks to see if they will consider extending this out to 18 months.
- **Cyber Update** We are currently negotiating with numerous carriers and will have an update on the cyber renewal at a future meeting. Please continue to schedule cyber interviews with Harbor Technology.
- Guest Speaker: Mr. Michael Markulec of Harbor Technology Mr. Markulec spoke to the current environment of the cyber marketplace and highlighted several key areas we will be focusing on in the upcoming year.

RISK CONTROL REPORT (Anthony Ven Graitis)

- Safety Monthly Meeting Recap:
- **Distracted Driving Awareness Results** The 3rd annual Distracted Driving Awareness challenge has officially ended and was a great success. The challenge took place from April 1st to April 30th , during which 4,377 courses were completed, and 21 municipalities participated. It could not have happened without the support of commissioners, department heads, command staff, and risk managers. Thank you and congratulations to all. Holmdel Township finished in first place, Monroe Township finished in second place, and Warren Township finished in third place. Morris Township , Borough of New Providence, Neptune Township, Aberdeen Township, Borough of North Plainfield, Town of Kearny and Borough of Jamesburg received honorable mention for their efforts.



- No Accidents Today is more than just a fleeting trend—it's a philosophy and a way of life. Grounded in science and supported by extensive literature, it emphasizes the power of positive affirmations to drive behavioral change. The ultimate goal? To create a workplace where every employee returns home safely at the end of each day. No Accidents Today will replace the current Safety Incentive Program, will reward members for their safety performance, but most importantly, will emphasis a safety culture where every loss is preventable.
- **Tree Care Safety** Loss control discussed that PEOSH is following OSHA's lead in inspecting tree care operations. As one of the most dangerous jobs in the Country, tree care work requires working with heavy equipment, objects with varying centers of gravity, hazards that are not always readily seen, and working from heights. Risk control staff have resources to assist members, and expert third party providers are available for consultation.
- Lightning Safety PEOSH alert #38. Each municipality with outdoor workers must have a written plan in place to identify jobs that expose workers to lightning and addresses mandatory training. Risk control has distributed the PEOSH alert, OSHA Fact Sheet and USLA Lifeguard Guideline that references lightning and what to include in the plan.
